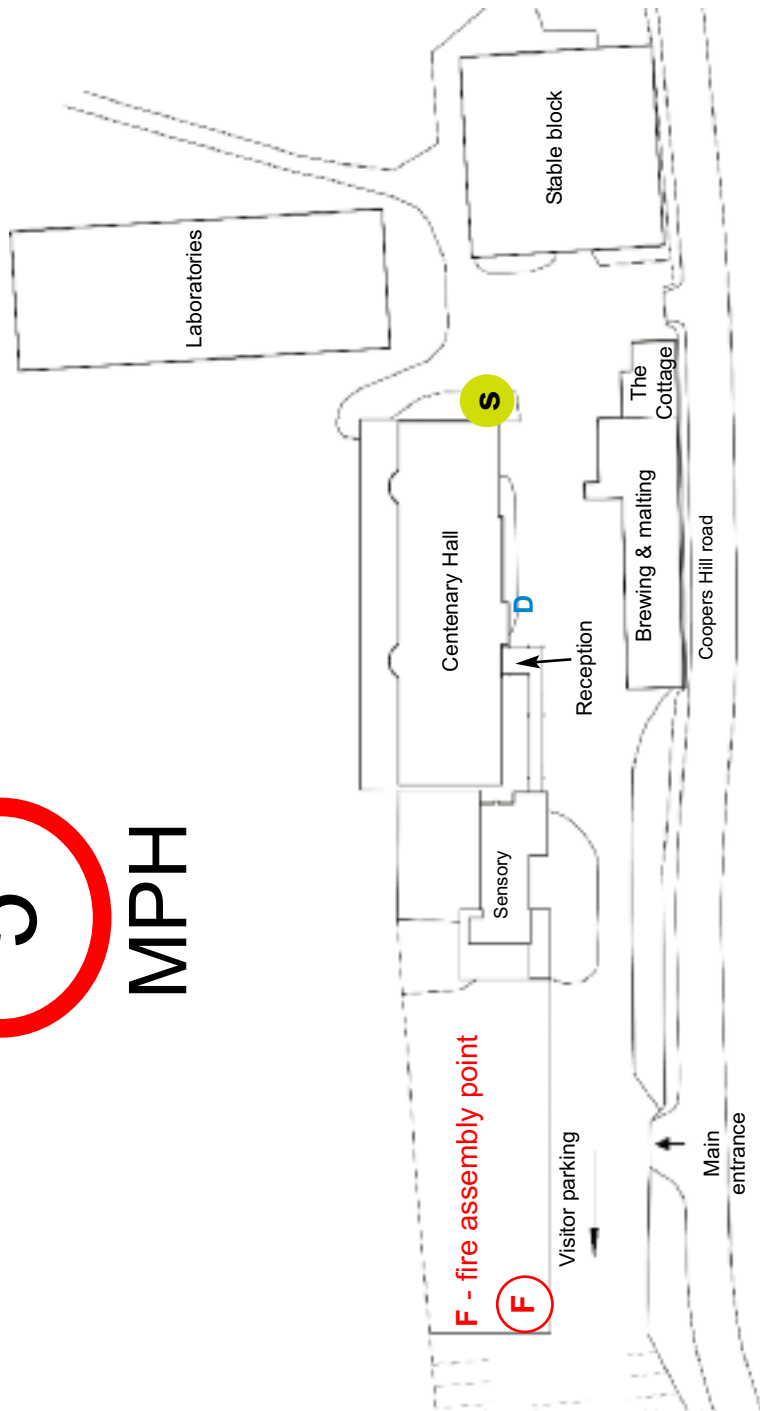
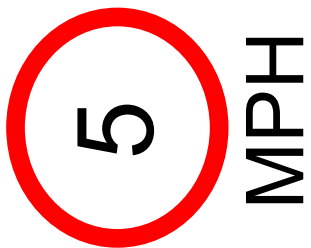

We hope your visit is enjoyable and informative. Please comply with the following health, safety and security safeguards.

Driving - there is a strictly enforced speed limit of 5 mph across the whole site. The use of hand-held mobile phones whilst driving around site is prohibited.

Parking - please use the visitor car parking spaces (disabled parking is available).

Pedestrians - please take care and be aware of vehicles accessing the site as there are no designated foot paths for pedestrians.

The network provision is at our discretion and access to the network may be blocked, suspended, or terminated at any time for any reason.
